COMMON CAUSE LED EFFORTS ACROSS THE COUNTRY ON BEHALF OF AUTOMATIC VOTER REGISTRATION: THROUGH LEGISLATIVE OR ADMINISTRATIVE ACTION, OREGON, CALIFORNIA, AND CONNECTICUT HAVE ADOPTED AUTOMATIC REGISTRATION. IN OREGON, THE FIRST STATE TO MAKE THE MOVE, MORE THAN 51,000 VOTERS WERE REGISTERED AUTOMATICALLY IN THE FIRST FIVE MONTHS OF 2016. THE ILLINOIS LEGISLATURE PASSED AUTOMATIC REGISTRATION BUT THE BILL WAS VETOED BY GOV. BRUCE RAUNER. MARYLAND LAWMAKERS AGREED TO PROVIDE VOTER REGISTRATION AT MULTIPLE STATE AGENCIES; COMMON CAUSE CONTINUES TO LOBBY THERE FOR AUTOMATIC REGISTRATION.
