

## **Common Cause Education Fund FY2014 Accomplishments Highlights**

The Common Cause Education Fund (CCEF) works to increase public understanding of the democratic process and, where appropriate, the need for change, in addition to promoting effective citizen participation at local, state and federal levels. The CCEF educates and engages the public through the dissemination of research, outreach to mainstream and alternative media, social networking, town hall meetings and through convening policy experts and reform groups. We reach out to community leaders, policy makers and officials, and work in coalition with diverse partners to achieve our goals and broaden the impact of our work. Common Cause's 35 state organizations play a central role in achieving the organization's mission.

The Common Cause Education Fund (CCEF) had notable accomplishments in Fiscal Year 2014 in the areas of **Voting and Elections, Money in Politics, Media and Democracy and Ethics, Transparency and Accountability in Government**. The following is a description of the highlights.

### **Voting and Elections**

When the Supreme Court gutted a key provision of the Voting Rights Act, CCEF worked closely with other lead groups to create a national strategy to engage and train state leaders and advocates about protections lost in the Voting Rights Act due to recent Supreme Court decisions, and how to protect voters from racial discrimination in voting. CCEF also organize field hearings in the states focusing on voting issues and building a case for the restoration of preclearance requirements.

Some state legislatures enacted laws aimed at reducing participation by racial minorities and other groups. In North Carolina, CCEF supported work related to Common Cause's role as a plaintiff in a federal lawsuit challenging a new state law that dramatically restricts early voting opportunities, eliminates same-day voter registration during early voting and imposes an unneeded voter ID requirement. In Arizona, CCEF supported Common Cause's role as plaintiff in a case that persuaded a 7-2 Supreme Court majority to strike down a state law requiring prospective voters to produce proof of their citizenship beyond that already required by the National Voting Registration Act of 1973. And in Florida, CCEF supported Common Cause's service a plaintiff in a successful lawsuit challenging congressional districts the legislature drew following the 2010 census.

Additionally, CCEF, worked directly with election officials and a diverse group of partners to strengthen election administration and pushed back against voter suppression attempts. It also worked to halt the rush toward Internet voting until such systems can be proven secure and verifiable.

CCEF convened a diverse array of civil rights, good government, and community organizations to discuss issue areas related to redistricting reform, including litigation, policy advocacy, educating the media and the public, and transparency and data in decision-making. And in North Carolina, CCEF led the effort to create North Carolinians to End Gerrymandering.

## **Money and Politics**

CCEF worked extensively to educate the public about the U.S. Supreme Court's efforts to undermine well-settled law governing campaign finance reforms long supported by Common Cause, encouraging discussion about the range of possible policy responses, including a constitutional amendment, public financing, and improved disclosure.

CCEF work supported Common Cause's comments filed in response to an IRS/Treasury Department notice of proposed rulemaking urging the IRS to adopt rules that would reign in money from undisclosed sources influencing elections.

We continued to expose efforts of the American Legislative Exchange Council (ALEC) to exert corporate influence over the legislative process at the state level. As of June 2014, over 100 had dropped their memberships in ALEC. With allies, CCEF continued to press the Securities and Exchange Commission to promulgate a rule requiring public companies to disclose all political spending.

CCEF supported Common Cause California's win of a significant victory in the fight against political "dark money" as the state levied a record \$1 million fine on a pair of Arizona non-profit groups that pumped \$15 million from hidden donors into two state ballot initiative campaigns in 2012. In addition to the fine, California is seeking to recover the \$15 million that was donated.

And we supported Common Cause filings of amicus briefs defending Connecticut's campaign finance laws from partisan efforts to undermine the state's public financing system.

## **Media and Democracy**

CCEF educated and engaged citizens, opinion leaders and policy makers about the need to put the public interest first in a rapidly evolving media environment and to fight for universal access to open and diverse media platforms critical to our functioning as a democratic society.

CCEF engaged grassroots in dialogue about the Federal Communications Commission's consideration of a plan to depart from long-standing Open Internet principles, generating 26,000 petition signatures in support of strong Open Internet guarantees.

CCEF communicated the reasons for our opposition to the proposed Comcast-Time Warner Comcast merger vigorously, through press outreach, member engagement, and a series of public events.

CCEF protested the potential sale of the Tribune Co. newspapers to industrialist billionaires Charles and David Koch, concerned that they would use these critical community institutions to advance their own profit-driven agendas. The Kochs later announced that they were dropping plans to buy the newspapers.

### **Ethics, Transparency and Accountability in Government**

CCEF Pursued litigation challenging the constitutionality of the Senate's sixty vote cloture rule. It also engaged in research and public education around the causes of congressional gridlock and the historic backlog of unfilled executive branch appointments requiring executive confirmation. Relatedly, CCEF released a widely publicized report, "The New Nullification at Work: Executive Branch Nominations and the Tactics of Obstruction."

CCEF sponsored a congressional briefing to educate Members of Congress and congressional staff about why the Supreme Court should adopt a judicial code of conduct. It also organized a coalition letter to the House Ethics Committee asking to reverse its decision of eliminating the inclusion of privately-funded travel information in lawmakers' annual financial disclosure forms. And CCEF joined the "Ethics Working Group" coalition to participate in regular meetings to strategize about strengthening the congressional ethics process.
