Part I: Introduction

Part I: Introduction

As the Maryland General Assembly debates legalizing slot machines for the third year in a row, new data released by the State Board of Elections shows that businesses, PAC's, and individuals who promote organized gambling in Maryland gave a total of \$166,525 to candidates and political committees in the state from 1/13/04 to 1/12/05. Of this total, \$118,545 was given by corporations and PAC's, and \$47,980 by individuals. Since 1999, over \$840,000 has been given by such donors, some of whom stand to reap hundreds of millions of dollars in profits should slots be legalized.

Three of the most generous donors in this year's study are currently lobbying for licenses to operate slot machines.

- Racetrack owner William Rickman, who in the past has exceeded the state's \$10,000 limit on contributions in an election cycle by funneling extra contributions through entities under his control, once again topped the list with \$42,875 given through seven different entities. Since 1999, he has given a total of \$226,440 through various entities. Mr. Rickman and members of his family have personally given \$37,520 since 1999.
- This year's study includes contributions from Peter G. Angelos and entities operated out of his law offices, as the Maryland Racing Commission approved the sale of Rosecroft Raceway way to a group headed by his wife and sons Louis Angelos and John Angelos on 1/11/05. Since the first day of the 2004 session of the General Assembly, \$15,250 has been given through entities operated out of his law offices (another \$500 was given by Mr Angelos personally). State law also limiting candidates to receiving \$4,000 from a single donor in an election cycle, Gov. Robert Ehrlich received \$4,000 from PGA Court Towers Ltd. Partnership, \$4,000 from PGA One Charles Center L.P., and \$4,000 from Peter Angelos's Artemis Properties—all on 1/7/03. On 1/11/05, Ehrlich received another \$4,000 from the newly formed Artemis

Texas LLC, whose principal office, according to the MD Department of Assessments and Taxation, is Peter Angelos's law office in Baltimore. Since 1999, \$141,725 has been given by Peter Angelos's law firm and by eleven different entities whose principal office is his law firm, in addition to \$46,875 by Peter Angelos and members of his family. **For all contributions by entities associated with Peter Angelos, see Part V.**

- Maryland Jockey Club President Joseph DeFrancis gave \$6,975. Nothing was given by the Maryland Jockey Club or the Laurel Racing Association (the title holding company for Laurel Park), a remarkable drop-off given that the two organizations gave \$32,875 and \$32,262 respectively from 1999 through January of 2004.

Recommendations

As in years past, this year's study demonstrates several weaknesses and loopholes in Maryland's campaign finance laws.

- The contributions from individuals associated with organized gambling found in Part III of this study represent only those employees, members, board members, and other key individuals whose identities could be verified independently by Common Cause Maryland. **Maryland does not require big campaign contributors to disclose their employer to the State Board of Elections.**
- Different corporate partnerships with the same partners, and different LLC's with the same members, can make contributions as if they were separate entities—up to \$10,000 by each entity in any four-year cycle.
- **Donors can give more than the legal limit to a candidate by making additional contributions to slates to which that candidate belongs,** whereupon the slate can transfer the donation

into the candidate's account (disguising the donor's identity in the process, given that Maryland slates collected hundreds of thousands of dollars from thousands of donors in the last election cycle).

Gambling Contributions to Federal PAC's

Contributions to Federal PAC's which give to state legislative candidates are another way for organized gambling to influence state politics. In 2002, racetrack owner Joseph DeFrancis gave \$225,000 to the Democratic Legislative Campaign Committee, a Federal PAC then chaired by Maryland Senate President Mike Miller.

That year the DLCC gave \$54,000 to seven Assembly candidates and two political committees in Maryland.

Looking ahead to Maryland's 2006 election, neither the DLCC nor the RSLC (the Republican State Leadership Committee, which is the biggest Federal Republican PAC supporting state-level candidates) gave to candidates in Maryland in 2004, but both received the following contributions from organized gambling which could be funneled to candidates in Maryland in the future. Sen. Miller no longer chairs but still serves on the board of the DLCC, while the RSLC oversees the Republican Lieutenant Governors' Association, to which Lt. Gov. Michael Steele belongs.

Angelos Family: A group headed by Peter G. Angelos's wife has negotiated to buy the Rosecroft raceway.

HORSEMEN: Owners, breeders, trainers, riders, etc. of horses. Horse racing drives this industry. As Bill Boniface puts it, "The larger our purses, the bigger the fields. The bigger the fields, the larger the handle. The larger the handle, the bigger our Fund. People will pay more for a Maryland-bred horse if it can earn more. If it can earn more, everyone wins." Slot machines mean bigger purses.

MHBA: The Maryland Horse Breeders Association promotes and organizes all aspects of the thoroughbred community, including racing. MHBA would like to see slots provide an infusion of cash into the Maryland horse industry and competition with the slots funded purses of West Virginia and Delaware. "My guess is that slot machine legislation will begin in earnest following the gubernatorial election in November. By this time next year, a Maryland gaming bill will be moving through Annapolis. What will be the future of the racing industry in this game of chance? Will it be "race tracks only" for slot locations? What other sites are possible? Who will be in control? Will the race tracks be in the center or on the outside? Our success depends upon our ability to coalesce, mobilize and utilize our resources." Michael Pons, former MHBA.

MDJC: The Maryland Jockey Club operates Pimlico and Laurel Park while they are majority owned by Magna Entertainment Corp. This arrangement is as of July 15, 2002. Prior to that Joseph De Francis was the sole owner, having inherited the position from his father. Leucadia National Corporation held a large non voting share. The interest in the thoroughbred tracks was purchased by LUK-Flats, L.L.C.

CSOA: The Cloverleaf Standardbred Owners Association is an organization of owners, driver, trainers, etc. involved with the Maryland harness horse industry. Cloverleaf Enterprises (a subsidiary of CSOA) owned and operated Rosecroft Raceway until it was purchased by Centaur Inc. in October.
