The Six Million Dollar Loophole

How to Get the Attention of Elected Officials Who Are Focused on Raising Money

It is not uncommon that interests seek to move large amounts of money into campaigns, in spite of contribution limits that are in place to prevent this concentration of power. In Maryland, an easy way to concentrate the power of campaign giving is to use the limited liability company/limited liability partnership (LLC/LLP) loophole. This Common Cause Maryland study looks at the ways the LLC/LLP loophole has been used to funnel over \$6,000,000 into campaigns during the 2003-2006 election cycle. (See Appendix A for data on the recipients of this largess.)

For better or worse, campaign contributions get the attention of legislators and other elected officials; the more a contributor is able to bring to the table, the more impact it has and the greater the chances of obtaining attention. The campaign funding system in Maryland favors interests with money and encourages candidates to engage in the money chase using all available tools.

Until there is a better way to fund our campaigns – like the public funding systems in place in a growing number of jurisdictions -- candidates and givers are enticed to use all means that are available to meet their needs.

How LLCs and LLPs are Treated Differently from Corporations

Under current Maryland law, now matter how many LLCs or LLPs are owned by the same interest, each may make campaign contributions up the legal limit. Corporations, on the other hand, are treated collectively under the contribution limits if they have common ownership.

Each LLC or LLP may legally make contributions up to \$4,000 per candidate/committee and up to a \$10,000 total during a four-year election cycle. All corporations that are commonly owned are treated as one when applying contribution limits. Their contributions are calculated collectively against the \$4,000 and \$10,000 limit; all together they may contribute no more than a total of \$4,000 per candidate or \$10,000 for all candidates during the cycle.

Here is How it Works

To use the LLC/LLP loophole in the law, a person or corporation may do the following:

- create a legal entity called a limited liability company or partnership;
- register this entity with the Maryland Department of Assessment and Taxation (DAT), paying \$100 to register.
- designate a resident agent and an official address in the state; and
- contribute money to candidates or committees in the name of each LLC or LLP, up to the \$4,000/\$10,000 limit.

The Six Million Dollar Loophole

NOTE: The name of the owner of an LLC or LLP does not have to appear on the registration documents. The law allows a designated agent to act as the person with the authority to register the business. Many businesses are registered with the Maryland DAT in this way. (See Appendix B).

Evidence of Intent to Use the LLC/LLP Loophole to Pile on the Money

The LLC or LLP loophole is used in several ways. For instance, the following demonstrate intent to use the loophole to move more money than would otherwise be allowed.

- create limited liability companies and keep ownership secret, thus avoiding public disclosure of contributor identify – except to the candidate who receives the check;
- give money through limited liability companies or partnerships created for particular business projects, maximizing the impact of the money given to favored candidates -- personal contributions and corporate contributions add even more.
- use LLCs and LLPs to spread money broadly to candidates throughout the spectrum, maximizing your influence and access;
- entice contributors to give more than the maximum \$4,000 to your campaign by reminding them of the loophole in the law

Piling On

On January 10, 2006 Robert Ehrlich raised \$130,750 from businesses, part of a total of \$203,805 raised on that date. LLC businesses contributed \$89,500 of this total, or sixty-eight percent (68%) of the business contributions made.

Forty-one percent (\$59,000) of the business total came from eighteen LLC businesses that had never made a political contribution before; they were, in fact, registered with the State of Maryland only a few months to a few weeks before the date of the contributions.

All eighteen LLCs had these things in common.

1. resident agency companies filed each LLC registration, acting as the “person” with authority to do so;
2. the records at the Department of Assessment and Taxation in Baltimore do not reveal ownership, or a hint of the ownership, of these businesses; and
3. most of these LLC businesses made donations at the \$4,000 limit to Ehrlich on a single day, January 10, 2006.

Since we cannot know who owns these businesses, we cannot know which interests they represent, or how much owners gave through other conduits.

The following list has registration and contribution information on the eighteen new LLCs. It includes the amount each gave to Ehrlich on January 10, 2006, the date they were registered with the Maryland DAT, and the identity of the registering agency.

Giving Until It Hurts

Owners of corporations and LLC/LLP businesses often give several checks to a candidate on a single occasion, hiding from the public the total they have given by identifying business as the giver. If the identity of the owner of the business is not obvious, large amounts of money may be given in support for a favored candidate. The following shows how the owner of several LLC's gave Doug Duncan \$62,000 on one occasion, expanding his and his family's personal contributions of \$4,000 each.

Spread the Money Over Many Campaigns

Many times the owners of LLCs spread the money across party lines, contributing to competing candidates – sometimes giving checks on the same date.

For instance, the owners of Xavier-Clinton LLC, Xavier-Kensington LLC, and the Rivercrest Health Services LLC, gave the following to two gubernatorial candidates from different parties, Martin O'Malley and Robert Ehrlich, on or about the same date:

Lump Contributions With Partners

Some LLC owners use a range of contribution opportunities to make attention-getting contributions. For instance, the developers of the Inner Harbor East section of the Baltimore Inner Harbor – John Paterakis, Ronald H. Lipscomb, and William Struever – make creative use of combining business contributions from different LLCs to make a bigger statement. December 9, 2005, they creatively gave \$13,000 to James T. Smith, County Executive of Baltimore County. They used the following conduits.

Hey! You Can Give Me Even More!

If people didn't already know about the LLC loophole, some candidates will tell them about it. Montgomery County Councilmember Steve Silverman, who is running for the post of County Executive, included the following statement as a footnote to a recent invitation to a fundraiser:

Individuals or entities such as corporations, LLCs or partnerships may each contribute up to \$4,000 to "Citizens for Steve Silverman." Spouses may each contribute under a separate \$4,000 limit.

The Councilmember may have found the right formula for using the LLC loophole to raise funds. His receipts from the LLC and LLP sector have increased greatly over what he received in the 1999-2002 cycle. In 1999-2002 he received approximately \$16,000. In this current cycle, he has received over \$157,000; and, the race isn't over yet.

What to Do?

The \$6,000,000 loophole must be closed. It carries with it the potential for mischief, creating a system that invites the owners of businesses to pile on the money, hiding the identity of the interest represented.

The public interest is not served when a campaign contribution cap does not effectively address the potential for corruption. The U.S. Supreme Court has said many times that government may set a threshold for contributions made to political campaigns and candidates. The government may do this, the Court has said, because the protection of the public from a corrupted system trumps an interest in an unfettered system of money flowing into campaigns.
