**OVER THE TOP:
100 CORPORATIONS EXCEED
THE LIMITS OF
NEW YORK STATE CAMPAIGN FINANCE LAW**

**A COMMON CAUSE/INY – NEW YORK PUBLIC INTEREST
RESEARCH GROUP (NYPIRG) INVESTIGATION**

During the months of February, March and April of 2003, researchers from Common Cause and the New York Public Interest Research Group (NYPIRG) fanned out across New York State to examine compliance with campaign finance law limits for corporate donors. After reviewing all corporate donations filed in fourteen County Boards of Elections and the State Board of Elections, this report finds that 96 corporations apparently violated campaign contribution limits in 2002 (a listing of those corporate contributors is attached as an appendix).

This report should act as a wake-up call to New York State lawmakers. Corporate violations of New York State's campaign finance law have been long documented, but little has been done to strengthen oversight. Modern technology must be enlisted and campaign finance reforms must be enacted to address this critical issue.

KEY FINDINGS

FINDING: Existing campaign finance laws are not being enforced. Our organizations conclude that corporate – and other aggregate – limits are ignored. Moreover, it is virtually impossible for the corporate contribution limit

to be enforced. According to our investigation, 96 corporations apparently made campaign contributions in excess of New York State law.

We cannot be sure that all corporations listed did, in fact, break the law. Our researchers did not verify that corporate donations were all from one company organized as a single corporation. State law allows corporations to circumvent contribution limits by donating through subsidiaries. Nor did our researchers verify that campaign filings correctly identified donors as corporations. There are some contributors that are listed as "corporations" by political committees that seem likely to be either partnerships or political action committees (both of which are not subject to corporate limits). Moreover, some forms were hard to read (see attached). Only an investigation by the State Board of Elections can verify our findings. However, since our researchers did not review filings for all of the state's 62 counties, it is likely that the number of violations is significantly greater than revealed in this investigation.

FINDING: Paper files are not always easily accessible. In some counties, our researchers were faced with inaccurate, incomprehensible, and/or illegible paper files at the County Board of Elections. In addition, some County Boards of Elections were uncooperative or hostile to our requests to review contributions. For example:

- Nassau County's Board of Elections was the most unhelpful. When our researcher showed up unannounced to examine campaign filings, she was turned away and told to make an appointment. When researchers made the appointment and showed up one week later, County Board staff constantly monitored every action of our researchers.
- Rockland County would only allow our researchers to examine campaign filings after an appointment was made and as long as the staff of the County Board of Elections could visually monitor our researchers.
- New York City's Board was initially unhelpful and its filing system difficult to use. Over time, a more cooperative relationship developed.
- Not all counties created problems. Albany, Broome, Monroe and Onondaga county boards were cooperative and helpful.

Suspicious and uncooperative public servants blocking easy access to public documents should not frustrate members of the public. The public deserves a more open system.

THE PROBLEM – NEW YORK ELECTION LAW IS UNENFORCEABLE

Since 1974, New York State election law has limited corporate campaign donations to no more than \$5,000 in total political activity in a calendar year for

state and local elections.¹ The limit was enacted to curtail the influence of corporations, whose deep pockets give them an advantage in the political arena. The State Board of Elections, not counties, is charged with enforcing that limit. However, political filings are required to be submitted to County Boards of Elections for county, city and town races and to the State Board of Elections in Albany for statewide, state legislative and state supreme court elections. Political committees that contribute to local or state races are also required to file with either the State Board or County Boards depending on the type of candidacy.²

Unfortunately, there is no system for the State Board – which is charged with enforcement – to inspect disclosures at the county level. Nor does it have the resources to travel to all 62 counties and inspect corporate filings to ensure compliance. Corporations are not required to file records of their annual political donations. As a result, an enforcement “black hole” exists that allows corporations to – wittingly or unwittingly – exceed legal contribution limits. This dual disclosure requirement is at the heart of why the aggregate corporate contribution limit is unenforceable.

THE PROBLEM HAS BEEN IDENTIFIED IN THE PAST, BUTLAWMAKERS HAVE NOT ADEQUATELY REFORMED THE SYSTEM

Over the years, researchers from the media and government have conducted investigations to document the problems of New York’s limits on corporate contributions.

In 1988, 1989 and in 1996, *Gannett Suburban Newspapers* conducted investigations into corporate compliance with New York State Election Law. Their analyses found:

- In 1988, 55 corporations apparently exceeded the limit.
- In 1989, 87 corporations apparently exceeded the limit.
- In 1996, 209 corporations apparently exceeded the limit.
- In 1996, 32 of the corporations apparently over the limit were companies identified in earlier reports.³

In 2000, the Office of the State Comptroller released a report identifying 34 potential violations of campaign contribution limits at 7 different Boards of Elections.⁴

WHAT WAS DONE

The reports mentioned above did receive attention from state lawmakers and did stimulate responses – although no real changes resulted that would have prevented future problems.

In 1990 in response to the *Gannett* findings, the State Board of Elections computerized corporate filings at the state level, in an effort to identify illegal corporate donations to state candidates.

In 1996, Senate Majority Leader Bruno introduced campaign finance changes that included a requirement that all political committees – both state and local – file electronically with the State Board of Elections. The bill was not an exact match with Assembly legislation and was introduced too late in the session for an agreement to be negotiated.

In 1997, at the request of the Assembly, the state budget included legislation that mandated the development of an electronic system for political committees' financial reporting – but only for those committees required to file with the State Board. The law went into effect in 1999.⁵

After the 1999 change went into effect, legislation was introduced in both houses, but there was no legislation action. In a 2001 program bill that proposed comprehensive campaign finance reforms, Governor Pataki called for electronic disclosure of local contributions as a way to bolster campaign finance limit enforcement.⁶

It wasn't until the 2003 session that legislation was introduced in both houses that solely addressed the problem of corporate contributions at the local level.

RECOMMENDATIONS

RECOMMENDATION: Enact legislation to create a system of electronic reporting for campaign contributions at the local level. Currently, candidates for state office and political committees report to the State Board of Elections in electronic format. This contribution and receipt information is stored on the State Board of Elections website for accessible public inspection.⁷ Legislation must be enacted to expand that system to include candidates and political committees spending \$1,000 or more on elections at the local level.

Legislation has been introduced to implement this recommendation. State Senator Robach (R-Monroe) and State Assemblymember Galef (D-Westchester) have introduced legislation to require that all candidates and political committees file electronically. The Senate bill (S.2373) has already been reported from the Senate Elections Committee and is now on the Senate floor awaiting action. The Assembly bill (A.6562) has not been acted upon.

The legislation would impact:

- **The Public.** This legislation makes it easy for concerned citizens to inspect documentation of campaign receipts and expenditures for candidates and political committees involved in local elections. The bills require that paper filings be kept at County Boards of Elections for those members of the public without Internet access.
- **Candidates and political committees.** Candidates and political committees involved in local races would have to report in electronic format to the State Board of Elections if they receive \$1,000 or more. The information would be made available on the State Board of Elections' website. The legislation helps ensure that corporate limits are monitored, thus helping candidates keep track of how close companies are to contribution limits.
- **The State Board of Elections.** In addition to adding this new information to data existing on its website, the board would be able to monitor compliance with aggregate contribution limits and, if necessary, enforce existing campaign finance law.
- **The new requirements would not harm candidates of modest means. Current law allows a "hardship exemption" for candidates who may not be able to afford computer technology.** Contributors and political committees spending \$1,000 or more incur the only costs. Current law includes a "hardship waiver." This program has been successful at the state level, and could now expand this success to reporting at all levels at virtually no cost to taxpayers.

RECOMMENDATION: Close the corporate loophole. New York's corporate limit applies to each corporate subsidiary separately. This loophole in the law allows multi-subsidary corporations to funnel multiple donations to candidates and the political parties, with each subsidiary company able to donate \$5,000. New York State law should be amended so that the \$5,000 limit applies to the entire corporation.

RECOMMENDATION: Strengthen enforcement. Current election law requires that all contribution violations be “knowing and willful.”⁸ In the case of corporate violations, this means that corporate officers cannot be held for a violation if they did not fully know of the existence of the statute. Furthermore, the law stipulates that the State Board must refer all violations to District Attorneys for prosecution. Few of these cases get referred and fewer still get acted upon. New York State should create a new campaign finance enforcement agency with real powers to enforce the law.

RECOMMENDATION: Overhaul New York’s campaign finance and create a new system modeled on the enormously successful New York City program. Many states have developed voluntary systems of public financing – nearly half the states operate some sort of public financing program.⁹ However, New York State lawmakers do not have to look far for a model of how to reform its campaign finance system. Described by *The New York Times* as “the best and fairest way for candidates to run for political office,”¹⁰ New York City has a system of public financing of elections that is a model for the nation. As a result of its 4 public dollars for every 1-dollar raised from small private donations, New York City now has competitive elections in which average citizens have a shot at elective office. Moreover, once in office, those legislators now owe little to rich special interests. It is the model that state lawmakers should emulate in Albany.

Lawmakers must strengthen existing law for those who opt not to participate in the voluntary system. New York State can only create a *voluntary* system of public financing; it cannot force all candidates to participate. Unless significant changes are made to the existing campaign finance law, the benefits of a public financing system will be limited.

Luckily, there appears to be a consensus that New York’s campaign finance law needs to be reformed. Governor Pataki has proposed legislation (Senate bill 5553, 2002 session) that overhauls campaign finance law in a manner remarkably consistent with Assembly Speaker Silver’s legislation (Assembly bill 8524-A, 2002 session). The bills’ major difference is that the Speaker calls for the creation of a voluntary system of public financing and the Governor’s plan does not. The bills are in virtual agreement in many other areas, with only small differences:

- **Both bills ban soft money.** The federal government now bans “soft money” donations to the political parties. Yet, the federal law allows state and local parties to continue to receive these huge donations. New York State should close the soft-money loophole.
- **Both bills dramatically lower contribution limits.** Both bills lower contribution limits, but to different levels.
- **Both bills close significant loopholes.** Both bills eliminate the loophole that allows corporations to circumvent New York’s \$5,000 annual aggregate corporate limit by funneling contributions through subsidiaries.
- **Both bills expand disclosure.** Both bills require disclosure of the name of the employer or the occupation of the contributor.
- **Both bills strengthen enforcement.** The Governor’s bill goes beyond the Assembly bill by creating a new enforcement agency with the power to crack down on election law “scofflaws.”

METHODOLOGY

Researchers from Common Cause/NY and the New York Public Interest Research Group (NYPIRG) reviewed and analyzed campaign filings for all local candidates and party committees in New York City, Albany, Broome, Monroe, Nassau, Onondaga, Rensselaer, Rockland, Saratoga, and Schenectady counties. All “Schedule B” filings (corporate) were entered into a spreadsheet program. The information was then sorted and aggregated. Corporations whose donations exceeded \$1,000 or which gave multiple contributions were then matched with the State Board of Elections filings. Corporations that had aggregate donations in excess of \$5,000 were identified. Corporations that appear to have exceeded New York State Election Limits were then sent to the State Board of Elections for a follow up investigation (see appendix).

AN IMPORTANT NOTE

Our researchers did not verify whether the corporations identified were in fact separate subsidiaries. New York State’s aggregate limits do not apply to corporate subsidiaries – a huge loophole that allows larger corporate entities to circumvent the law. In addition, we did not verify if donors listed in “Schedule B” were, in fact, corporations. It seems likely that some of the donors were incorrectly identified as corporate contributors. Only State Board of Elections investigators will be able to check the accuracy of these filings.
