## Race for New York's Horse Racing Franchise

Three of New York State's largest horse racetracks are set to change management hands after December 31, 2007. For 52 years the New York Racing Association (NYRA), a registered nonprofit organization, has held tenure as the sole operator of the Belmont, Aqueduct, and Saratoga Racetracks. Now there are four business groups bidding for the lucrative operating rights. The competition has been fierce in the years leading up to the turnover, and big money has certainly played a significant role in attempting to influence politics. The bidders Capital Play, Inc., Empire Racing Associates, LLC, Excelsior Racing Associates, LLC, and NYRA have altogether spent \$2.2 million on lobbying and campaign contributions since 2006, under the auspices of many different names, addresses, and LLCs.

The bidding process itself has undergone a series of transformations. Last year, Governor Pataki's Ad Hoc Committee on the Future of Racing determined that Excelsior be given the rights. In March of 2007 Governor Spitzer announced that the venture would be reopened, and installed a new bidding process. All bidders would undergo an integrity review process, to include interviews, background checks, and business plan proposals for all three tracks, with consideration to improvements on the physical spaces and expansions in thoroughbred racing interests. This new process includes a collective price tag of \$3 million, which bidders are required to pay. In July, Governor Spitzer required new proposals because of various arrivals and departures in the groups, and announced that the operation of gaming and that of development and racing may be split.

The current figure of well over \$2 million dollars spent on lobbying and campaign contributions by the four bidders for the new racing contract is a pretty gamble: all bidders propose the use of video-lottery terminals (essentially digital slot machines), a proposal which, if approved, would bring in an estimated \$55 million in gross profit just for the state of New York. Not to mention, the three racetracks receive approximately \$2.7 billion in bets each year.
