# Hawaii County Ballots

Interesting Tidbits about the 2020 Primary Elections:

- Nearly 1,000 Ballots were received by County Clerks after 7 pm on August 8<sup>th</sup> and could not be counted.
  - **Pat Nakamoto said that Hawaii County did not receive any late ballots.**
- 3,100 ballots had to have their signature verification verified.
- Areas that traditionally see large voter turnout and those that also have interesting races (e.g., Mayoral race) saw the highest VBM increases:
  - D6 (Kailua-Kona, Holualoa, Kalaoa, Honokohau) 19% increase from 2016,
  - D7 (North Kona, North Kohala, South Kohala) 18% increase from 2016
  - D5 (Naalehu, Ocean View, Capt. Cook, Kealahou, Kailua-Kona) 17% from 2016
  - D1 (Hamakua, North Hilo, South Hilo) 16% from 2016

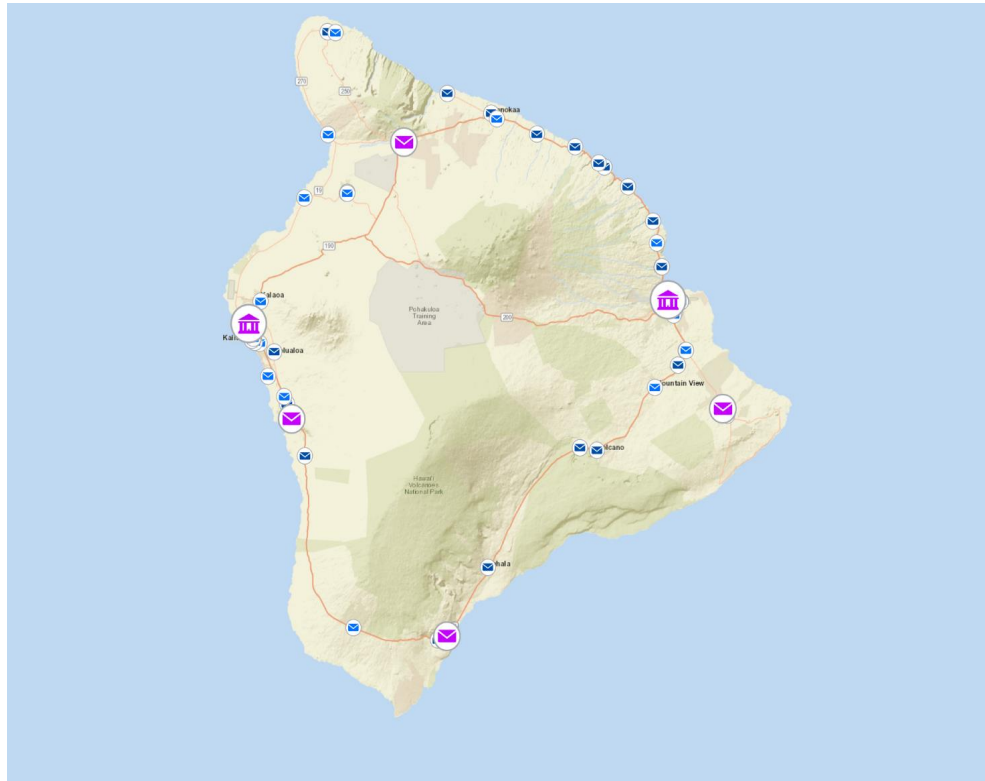
