Dear President Spilka and Speaker Mariano,

As you know, the state legislature is responsible for redrawing electoral district boundaries for state legislative districts and Congressional Districts this year. How these district lines are drawn influences who runs for public office and who is elected. The district boundaries are in place for the next ten years, and their policy impacts can last well beyond that. As leaders of the Drawing Democracy Coalition, we are optimistic that the 2021 redistricting process can be just as successful as the 2011 process if not more so, and bolster political power and participation in underrepresented communities.

The Drawing Democracy Coalition brings together the Commonwealth's community organizations, civil rights lawyers, public policy advocates, data and mapping experts, and political scientists, with the shared goal of partnering with you to ensure that underrepresented communities have the opportunity to elect candidates of their choice who best reflect their needs and interests. We anticipate that, on the tail of the 2020 election, Bay Staters will be eager to continue participating in our democracy and to advocate for the needs of their communities through a transparent and engaged redistricting process.

Our coalition has welcomed a fruitful, ongoing collaboration with Senator Brownsberger and Representative Mark, the Chairs of the Joint Committee on Redistricting during the 191st Session. During this new session, we look forward to being a continued resource for the Joint Committee on Redistricting, in order to maximize the participation of community members in public hearings, provide input on the draft maps, and more.

With this goal in mind, we strongly encourage the appointment of a **Joint Committee on Redistricting that reflects the rich racial and geographic diversity of our Commonwealth**. A diverse committee will lead to the best process and outcome for all stakeholders, and will allow all communities in Massachusetts - especially underrepresented communities - to play an active role in the redistricting process.

We would also like to extend our warm congratulations to Speaker Mariano. We look forward to working with you, President Spilka, and the Joint Committee to ensure a collaborative and participatory redistricting process in 2021.
