**Re: Our Members Demand DHS Funding Conditioned on Accountability,
Oversight, and Immediate Reform**

Dear Majority Leader Thune, Minority Leader Schumer, Chair Collins, Vice Chair Murray, Chair Britt, and Ranking Member Murphy:

We write as national, membership-based organizations representing millions of Americans in every state and across every congressional district. Our members are demanding urgent action from Congress in response to the escalating violence, lawlessness, and lack of accountability within the Department of Homeland Security and its immigration enforcement agencies.

In 2026 alone, federal immigration enforcement killed two U.S. citizens, Renée Nicole Good and Alex Pretti. In 2025, 49 deaths occurred in detention facilities. These deaths are not isolated or unpreventable incidents. They are the foreseeable result of a system that has been allowed to expand rapidly without guardrails, oversight, or accountability. The U.S. Constitution protects all people, including immigrants, and they deserve due process and equal protection under the law. That has not been happening, as DHS officers continue to harass and escalate in Black and Brown communities from California to Maine.

Our members have been clear: Congress must act now.

We are writing in the immediate context of negotiations over DHS funding. While the decision to strip the DHS bill from the broader appropriations package and avoid a shutdown is a critical interim step, it does not change the substance of the required action. The two-week extension must be used to secure real, enforceable reforms. Anything less—such as vacuous commitments for DHS to simply follow the law—would be unacceptable.

Our members are calling on us, and we are calling on you, to ensure that no additional funding for DHS or ICE is approved unless the following conditions are met:

- A nationwide moratorium on ICE surge operations in communities, not limited to Minnesota.
- Full and unconditional cooperation by DHS and DOJ with independent investigations into the killings of Renée Nicole Good and Alex Pretti and other violations of civil rights and law.
- Resignation or removal of Secretary Kristi Noem.
- Comprehensive systemic and structural reforms that bring immediate and enforceable restrictions and accountability to DHS, such as requiring officers to turn on available body-worn cameras during enforcement operations and ensure all surveillance footage is controlled by an independent entity and is publicly accessible; prohibit masks; and require clearly visible identification by officers. These are not radical demands. They are common-sense requirements rooted in constitutional principles, basic public safety, and the rule of law. Congress has both the authority and the responsibility to impose them.

Our members have already made their voices heard, and they will continue to do so. We will continue to facilitate direct advocacy with your offices throughout this negotiation period and beyond. This is our role as membership organizations, and this is what the moment requires.
